# 2. Terms of Product Purchase

### a) The Agreement

In addition to the Terms of Use, these terms and conditions ("the Product Purchase Terms") set out the additional terms and conditions under which you may purchase from RTL products appearing on this website. By completing the application process and purchasing products from this website, an agreement exists between you and RTL once RTL accepts an order. Each accepted order is a separate agreement.

# b) Customer Application

You must complete the customer application process before placing any orders. You warrant that all information and data provided by you is accurate, complete and up to date. You will promptly notify RTL if there is any change to this information or data. You must take responsibility for the safekeeping of your username and password, as you are liable if an unauthorised person uses your username and password.

### c) Product Availability

RTL uses its best endeavors to ensure products ordered are available for delivery, and in most cases will notify you when a product is unavailable prior to completing your order. However, you acknowledge that in some cases this is not possible, and RTL may need to reject an order you have placed for a product where RTL establishes that it is unavailable for delivery.

# d) Orders

You place a cash order with RTL by selecting products and pressing the "pay and complete purchase" button on the checkout page, or a trade order by pressing the "submit order" button. RTL reserves the right to accept or reject an order for any reason including, without limitation, unavailability of product; an error in the price, image or the product description; or error in your order. Cash orders are deemed received by RTL at the time of successful transmission of the order, and you will thereafter be unable to cancel the order. All other orders are deemed accepted by RTL upon RTL acknowledging such order or failing to reject such order within 14 days. We only accept orders from New Zealand.

## e) Cancelling your order other than a "Cash Order"

If you wish to cancel your order please contact us on 0800 785 744 or email us at sales@rtl.co.nz. If you cancel before your order is either manufactured or if a traded product is dispatched, you will receive a full refund. If your item(s) have already been made or sent, then your order can no longer be cancelled. Please note your delivery fee will not be refunded.

### f) Returns, Products Missing and or Damaged Upon Delivery

If you suspect your product has been damaged during delivery, please do not throw away the parcel or cover in which the product came as it will need to be inspected. Any claim for faulty or damaged products must be made within 3 business days from the date of receipt by you the "customer".

For return claims including replacement products, refunds or credits please contact our Sales Department on Ph: 0800 785 744 and one of our Sales Co-Ordinators will determine your entitlement to a return, replacement, refund or credit.

All returned goods must be unused, in original packaging and in saleable condition, and a copy of original packing slip should be enclosed stating the full reason for the return. Any returns must be made within 14 days following the date of the packing slips the goods were received on.

RTL reserves the right to charge a restocking fee equivalent to a maximum of 10% of the value of goods returned.

All refunds will be made to the card that you used to pay for your goods, or a credit against your trade account with RTL. Please note your delivery fee will not be refunded.

# g) Payment

You must pay for your "cash order" products purchased on this website at the time of placing an order. We currently accept the following credit cards - Mastercard and Visa. All payments via our site are processed using SSL (Secure Socket Layer) protocol, whereby sensitive information is encrypted to protect your privacy and security.

RTL does not store credit card details, and all payments are handles by a secure, PCI compliant, third party.

### h) Variation of Products and Price

RTL may vary the prices on this website at any time, and prices are subject to change until you have paid for the products in full. Product availability and product prices may vary from those found on this website.

#### i) <u>Delivery</u>

Please note that to purchase products, your delivery address must be provided in full, orders will not be processed for delivery if the address is invalid. Risk in property passes to you upon delivery to your nominated delivery address, and once you have signed for them as received and accepted in good condition. The title passes upon payment for the products in full. We reserve the right to refuse orders or negotiate delivery fees. We do not offer the ability to ship to multiple addresses at present.

### j) Delivery Times

Domestic orders are sent via Courier or freight depending on the size and quantity of the product and are usually dispatched within 1-3 days from the date you placed your order. The delivery time frame will depend on our stock levels. If we are unable to meet these deadlines, we will notify you via email or telephone. Orders received on Saturdays, Sundays and Public Holidays will be processed on the following business day. We aim to deliver your items as soon as possible but dispatch times indicated are subject to change.
